



PAMELA BRANDWEIN is a professor of political science at the University of Michigan. She is the author of *Reconstructing Reconstruction: The Supreme Court and the Production of Historical Truth* (Duke University Press, 1999), and *Rethinking the Judicial Settlement of Reconstruction* (Cambridge University Press, 2011). Currently, she is working on a book that reexamines the relationship between antislavery politics and capitalist development in the United States.

CHARLES J. COOPER is a founding member and chairman of Cooper & Kirk, PLLC. He served as a law clerk for Judge Paul Roney of the Fifth (now Eleventh) Circuit Court of Appeals, and to Justice (later Chief Justice) William H. Rehnquist. Mr. Cooper joined the Civil Rights Division of the U.S. Department of Justice in 1981. In 1985 President Reagan appointed Mr. Cooper to the position of Assistant Attorney General for the Office of Legal Counsel. Mr. Cooper is a member of the American Law Institute and the American Academy of Appellate Lawyers, and serves on the board of trustees of the Supreme Court Historical Society.

JUSTIN DRIVER is a professor of law at Yale Law School. He is the author of *The Schoolhouse Gate: Public Education, the Supreme Court, and the Battle for the American Mind*. A member of the American Law Institute and of the American Constitution Society's Academic Advisory Board, Professor Driver is an editor of the *Supreme Court Review*. He clerked for Judge Merrick B. Garland of the District of Columbia Circuit Court of Appeals and for Justice Stephen Breyer and Justice Sandra Day O'Connor at the Supreme Court of the United States.

MARK KILLENBECK is the Wylie H. Davis Distinguished Professor of law at the University of Arkansas School of Law. He is the author of *M'Culloch v. Maryland: Securing a Nation*, the first book-length treatment of that landmark case. He has contributed chapters to a number of works, including *The Oxford Guide to United States Supreme Court Decisions*, the *Encyclopedia of the Supreme Court of the United States*, and *Social Consciousness in Legal Decision Making: Psychological Perspectives*. Professor Killenbeck is an elected member of the American Law Institute.
